Insurance Bits 'N Pieces

INSURANCE COMPANY CHANGES

In this newsletter, Fun Times, you've learned about these insurance companies which are endorsed by CalRTA.....E.J.S. Insurances, Inc. and California Casualty Services. Over the years, they've increased in the services they've offered, that is, particularly E.J.S. Insurance Services. Very recently, we



all received information in our CalRTA CONTACT periodicals that E.J.S. Insurance Services had united with AMBA (Association Members Benefits Insurance Agency-Metlife).

With AMBA, many services are still available. Most recently, we all. also, received from AMBA, information for joining the dental insurance program. This is, of course, endorsed by CalRTA. *

California Casualty Insurance, in addition, has sent information to members regarding their services which include auto and home insurance coverages.

*(If you are currently taking advantage of the dental or vision insurance that MAY be included with your Senior Advantage plan, you might want to compare that plan with the one offered by AMBA to determine which, if either, is the best for your particular needs.)

GIANT HEALTH BILL

According to an article in the East Bay Times (January 23, 2023), "December's omnibus bill was also a giant health bill."

"The giant spending bill passed by Congress last month....quietly rewrote huge areas of health policy: Hundreds of pages of legislation were devoted to new health care programs.....The coming change made the omnibus bill a critical opportunity to pass pieces of legislation that might have withered in the new Congress."

INCOME-RELATED MONTHLY ADJUSTMENT AMOUNTS (IRMAA)

In November 2022, some CalRTA members may have received a letter relating to the Social Security Act. According to this Act, "some people are required to pay higher premiums for their Medicare Part B (Medical Insurance) and Part D (Prescription Drug Plan) based on their income. We use information the Internal Revenue Service (IRS) provides us to decide if you will need to pay these higher premiums. Based on your income, you are required to pay these higher premiums for 2023, which are called the Income-Related Monthly Adjustment Amounts (IRMAA). The IRMAA information is for one year only." Along with the letter, you will find higher premium amounts listed on the back of the letter from Social Security, which may apply to your situation.

"From" Spoofing: Using Your Name + Email Address By Marilynn Smith

Who's sending email from my email address?

Have you ever received email from your own email address? Or have friends told you they have, but you really didn't send anything? I think everyone has had this startling experience, but what can you do?

This spamming practice is called "From:" spoofing. Spammers know how to "fake emails to look like they came 'From:' email addresses that have nothing to do with them." That means yours and mine. And, as AskLeo says, "It's highly unlikely someone has hacked your account ... Annoying, but benign."

Try this: Use your favorite search engine and enter your own email address. What happens? Are you surprised? I certainly was! This is one way spammers find our email addresses, and none of us can control it. So don't sweat it! You can block and report it as spam or simply delete and move on!

Do you watch PBS stations on TV? They frequently have program breaks when they ask for pledge support to pay for the programs they purchase and we viewers enjoy. You'll hear them offer "sustained membership" where each month a chosen sum gets deducted from your credit card. They comment about their gratitude for this kind of dependable support.

CalRTA's Dues Deduct payment method is CalRTA's version of this. Since 2021 we have been offering a monetary incentive to cash-paying Division #91 members if they switched to dues deduct. HOW TO PAY WITH YOUR PHONE

Most smartphones and smartwatches offer a payment system that's more secure than using a credit card. With mobile payments, no personal information or account numbers are input into the retailer's computer system. Once you get used to it, paying this way can be quicker than using a card. Note that Apple Pay (for iPhones and Apple Watch) and Google Pay (for Android-based phones and smartwatches or Apple devices) work pretty much the same way.



Launch the device's preinstalled payment app. That's Apple Wallet for iPhones or GPay for Android devices.



Tap on the "+"
icon (Apple
Pay) or the "\$" icon,
then "Add an Account" (GPay), then
enter credit or debit
card information into
the fields. You can
add multiple cards
and select a default
card you use most.



When making a payment, launch the app, select a card (unless using your default card) and hold your smartphone or smartwatch near the merchant's credit card terminal.



Confirm the purchase. If you're using a debit card, you may also be asked to enter your card's PIN.
